



How to Become a VR Peer Mentoring Provider

Thank you for your interest in becoming a VR Youth Peer Mentoring Provider. Providers have two roles: Coordinator and Mentor. Providers must have at least one Coordinator and one Mentor on staff to deliver services. One person cannot hold both roles. Mentors must complete the Online Mentor Training with Policy Works. Coordinators must complete all of the steps outlined below.

✓ Complete the VR Process Training Modules	These five modules cover details about service expectations, referrals, deliverables and payment. ✓ Complete the VR Process Training Post Assessment	An assessment must be completed after viewing each VR Process Training Module. ✓ Complete the Youth Peer Mentor Coordinator Training	5 hours of training delivered in person and a field assignment delivered by Policy Works.	When training is available, a registration link will be emailed to providers by your Provider Manager. To be notified of future trainings, email VRTransitionYouth@vr.fldoe.org
✓ Complete the Youth Peer Mentor Training	20 hours of training delivered online by Policy Works.	Coordinators will be provided the link to access this training when they attend the Youth Peer Mentor Coordinator Training.
✓ Complete the VR Youth Peer Mentoring Provider Application	Registration is required to be identified in the VR system as a Youth Peer Mentoring Provider.	After you receive the certificate of completion from Policy Works, viewed all VR Process Training modules, and passed the related post assessments, the VR Vendor Registration Office will email the application to you.
